### **DESCRIPTION OF THE COMMISSION**

(Strategic Homeland Intervention, Enforcement, and Logistics Division) to stop the alien invasion led by Loki in the first Avengers film. As the MCU continues, the Avengers face various challenges and threats, from battling Ultron and his army of robots to trying to stop Thanos and his quest to gather the Infinity Stones. What sets the Avengers apart from other superhero teams is their diversity in of personalities, terms powers, and backgrounds. Each member brings their

unique set of skills and abilities to the team, allowing them to work together effectively and overcome any obstacle. They may not always agree on everything, but they share a common goal to protect the world and its people from harm. Throughout the MCU, the Avengers have become symbols of hope and bravery, inspiring people all around the world to stand up against injustice and oppression. They serve as a reminder that even the most powerful villains can be defeated when people come together and fight for what is right. Overall, the Avengers represent the best of humanity, and their story is one of courage, sacrifice, and heroism. GA Avengers is the classic version of the UN General Assembly, engaged in the universe of Marvel. This committee will address fictional scenarios of different outcomes that could happen in the Marvel Saga. During the debate, we will go back in time to explore 2 different topics which could have a different outcome, The Sokovia Accords Treaty and a Judgment for Wakanda. GA Avengers will work like a normal General Assembly in terms of





procedure, nevertheless, delegations will not only represent countries, for instance, delegations will enhance Marvel characters for delegation so in this way, there is a more clear understanding of what the delegation support and are against according to Marvel. In the MCU, the United Nations General Assembly would function similarly to the real-life UN General Assembly. the However, due to presence superheroes and advanced technology, the discussions and debates would be focused on the Sokovia Accords and the fictional nation of Wakanda. Regarding the Sokovia Accords, the delegates would discuss the implications of regulating the actions of the Avengers and other superheroes. Some delegates would argue that the Accords are necessary to prevent the collateral damage caused by the Avengers, while others would argue that regulating superheroes would undermine their effectiveness and ability to protect the world. The discussions would be intense and could potentially lead to a vote on whether to ratify or reject the Sokovia Accords. When it comes to Wakanda, the delegates would discuss the implications of country's resources, particularly vibranium. Some delegates may argue that Wakanda has a responsibility to share its resources with the world, while others may argue that it's Wakanda's right to keep its resources for its own use. The discussions may also address Wakanda's decision to

remain isolationist and the potential consequences of revealing the country's true capabilities to the rest of the world. Ultimately, the decisions made by the UN General Assembly in the MCU would have far-reaching implications for the future of the world and the actions of superheroes. The debates and discussions would be complex, and the outcome could potentially alter the course of MCU history.

## TOPIC A: LIMITATION OF AVENGER' ACTIONS, AND SOKOVIA ACCORDS

### **HISTORICAL CONTEXT**

The Avengers has been a private organization of superheroes that fight threats around the globe. In 2012 the avengers saved the world from an alien attack led by Loki (Thors Brother) in New York which Tony stark Saved by redirecting a bomb to the alien mothership, the world was saved but at what cost? The same happened in Johannesburg (Age Of Ultron) in which thanks to Wanda Maximoff, Bruce Banner (Hulk) got hypnotized and destroyed Johannesburg, Finally, that same year, the avengers saved the world again from Ultron, nevertheless, this conflict ended up in the complete destruction of Sokovia. After the attacks in 2012 in New York, 2015 Johannesburg, and Sokovia, The Avengers,,





intervened to stop Ultron and save the people of Sokovia. During the intense battle, the Avengers worked to evacuate civilians while fighting off Ultron's army of robots. Eventually, the Avengers destroyed the device that Ultron was using to lift the city, but the resulting explosion caused a significant portion of the city to collapse and fall to the ground, causing widespread devastation and loss of life. The United Nations declared "The Sokovia Accords" which stipulates that the avengers shouldn't be a private organization and that the United Nations protocols will lead it.

### **CAUSES**

The Avengers, a team of superheroes brought together by the government to protect the world from extraterrestrial and interdimensional threats, have saved the world from destruction on multiple occasions. However, their actions have also resulted in significant destruction and loss of life. In particular, the events in Sokovia, as shown in the movie Avengers: Age of Ultron, have raised questions about whether the Avengers should be held accountable for their actions. In Sokovia, the Avengers battle Ultron, an artificial intelligence created by Tony Stark, also known as Iron Man. The battle resulted in the creation of a large airborne city, which Ultron planned to use as a weapon to destroy the Earth. The Avengers ultimately

destroyed the city, preventing Ultron's plan, but at a significant cost. The destruction caused by the battle resulted in the deaths of numerous Sokovian civilians, and the entire city was reduced to rubble. While the Avengers saved the world from Ultron's plan, the consequences of their actions cannot be ignored. The destruction caused by the battle raises questions about whether the Avengers should be held accountable for their actions, and whether their actions in Sokovia were justified. One argument is that the Avengers should be held accountable for the destruction caused in Sokovia, as they were the ones who initiated the battle. The Avengers were acting without the authorization of any government, and their actions resulted in significant loss of life and property damage. The Sokovian government and its people were not given any say in the matter, despite being the ones most affected by the battle. The United Nations "Sokovia Accords" made this document for the particular reason that they didn't want to cause another threat on people's lives due to Avengers actions on trying to save the world. In 2012 after the Newy York battle, the total cost was 80 Billion dollars in damages, however the government managed to rebuild all damages with only 18 Billion dollars. The New York battle caused a total of 174 deaths, this number of deaths could have been much bigger but





thanks to the avengers, it was a lower amount of deaths. In 2015 in Johannesburg (South Africa) The Avengers attended a mission to intercept the illegal distribution of vibranium which ended up in a total destruction with an estimated cost of 20 billion dollars and a total death of 117 people. Finally in that same year 2015, The avengers saved the world once again in Sokovia, Ultron lifted the whole city and was planning on crushing it to the ground with a force that an destroy all earth and the avengers destroyed the whole city with making a cost of 474 billion dollars of damages to the city and total deaths of 177.

### **REPERCUSSIONS**

The Sokovia Accords were, in essence, a Superhuman Registration Act which was approved by 117 countries. Its approval forced superheroes to work under the mandate of the United Nations and not freely or under their own rules, as had happened until then. Anyone who did not comply with them became a fugitive from justice. This created a strong disagreement between the avengers which were divided into 2 groups. The first group which was in favor of The Sokovia Accords was composed of Tony Stark(Iron Man), Natasha Romanoff (Black Widow), James Rhodey (War Machine), Vision and T`achalla (Black Panther). On the other hand, the group which was against The Sokovia Accords is

composed of Steve Rogers (Captain America), Sam Wilson (Falcon), Wanda Maximoff (Scarlet Witch) and Bucky Barnes (The Winter Soldier). On Captain America Civil War, what happened was that after a group of avengers caused an explosion which caused approximately 20 civilian deaths in Lagos, the secretary of state Ross gave the avengers the Sokovia Accords, then the group divided and finally they had to fight each other which causes the termination of The Avengers. Hydra, a fictional terrorist organization in the MCU, was revealed to have infiltrated and breachedted S.H.I.E.L.D., peacekeeping agency. During the events of Captain America: The Winter Soldier, it was revealed that Hydra had been operating within S.H.I.E.L.D. for decades, using their influence to carry out their own agenda. In Avengers: Age of Ultron, Hydra's involvement in the creation of the villain Ultron is revealed. The organization had been using the research of Tony Stark's company, Stark Industries, to create advanced artificial intelligence, which they hoped to use as a weapon. When the Avengers attack one of Hydra's bases, they inadvertently come across this research and Stark decides to use it to create Ultron as a defense mechanism to protect Earth. However, Ultron quickly becomes a threat to humanity and attempts to destroy the world. In the final battle, Ultron uses





Sokovia, a fictional country in Eastern Europe, as a base to launch a global extinction event. The Avengers, with the help of the people of Sokovia, are able to stop Ultron and prevent the destruction of the world. While Hydra's involvement in the Sokovia attack is not directly shown, it is implied that they had a hand in the creation of Ultron and the events that led up to the attack. Therefore, it can be argued that the Avengers should be judged for their actions in Sokovia because they inadvertently allowed Hydra to create Ultron, which led to the destruction and loss of life in Sokovia. Additionally, the Avengers' actions in Sokovia had global implications and could have resulted in the extinction of all life on Earth.

### **CURRENT SITUATION**

Taking into account that this specific topic will take place in a historical context, we will be located after the secretary of state Ross gave the avengers the sokovia accords, delegates will have to discuss the decision of having the sokovia accords or not in this committee, at this point in the storyline, King T'chaka has not died which means that the prosecution of Bucky Barnes has not happened yet also meaning that during this committee, delegates will not focus on personal issues between avengers but how this conflict should be treated for a better world peace and security. Currently, the

Avengers are in a disagreement according to the Sokovia Accords treaty being able to prejudicate the future of the avengers a a groups, many of them assure that if they accept the Sokovia Accords, the avenger will not be able to safe all the possible threats that they can fight. On the other hand, the others assure that if they accept the Sokovia accords, the regulations will benefit people and will help preserve life. In other words, people can have a lower risk of losing their lives during an invasion, war, conflict or other threat to civilian lives on an international level.. However, the Accords were met with resistance from some of the Avengers, who believed that they would be limiting their ability to act and potentially putting people in danger by waiting for bureaucratic approval. One potential issue with the Sokovia Accords is that they were drafted without input from the superheroes themselves, which led to distrust and confusion about their purpose and scope. Additionally, the Accords placed a heavy burden on the Avengers to adhere to government regulations, which could be difficult given the rapidly changing nature of their work. On the other hand, the Sokovia Accords were designed to address real concerns about the actions of superheroes, who can cause massive collateral damage and sometimes act outside of the law. By requiring superheroes to register with the government and follow certain rules, the





Accords aimed to promote accountability and prevent unnecessary harm. Whether or not the Sokovia Accords should be reformed is a complex question that depends on a variety of factors, including the needs of society, the rights of individuals, and the effectiveness of existing regulations. It is important to consider the potential consequences of any changes to the Accords and to involve all stakeholders in the process to ensure that the final result is fair and effective.

At this point in the debate, the delegations are located as soon as the sokovia accords were suggested and the delegates will make

the choice if they agree or not. Taking into account that for this topic we will see a different outcome, delegations without an exact position on the agreement will have to support the decision of their closest allies. This conflict must start as a discussion and it will be solved in a pacific way or maybe not. The best way to treat this conflict may be with a reform to the sokovia accords, at this exact moment the sokovia accords state:

- Enhanced individuals that sign the Accords must register with the UN and provide fingerprints and DNA samples
- Those with secret identities must reveal their legal names and true identities to the UN
- Individuals are subject to a power analysis and must wear tracking bracelets if they have powers
- 4. Enhanced individuals that sign the Accords are prohibited from taking action in any country besides their own unless approved by their home government or the UN
- Enhanced individuals that do not sign are not allowed to participate in any police, military, or espionage





activities or in any national or international conflicts

- Enhanced individuals that use their powers to break the law (including those that defy the rules above) or are deemed a threat to the general public can be detained indefinitely without a trial
- The use of technology to give individuals powers or special capabilities and the use/ distribution of highly advanced technology is extremely regulated

Taking into account this aspect of the sokovia accords, the avengers will argue on how this can be reformed in difference to how it went on the MCU "Captain America-Civil War". Delegates will have the chance to create their own reforms as suggestions to be changed, nevertheless, not all delegations will not agree with some decisions due to how this can impact their role on the avengers or other organizations.

## ORIENTATION AND OBJECTIVE OF THE COMMISSION

GA Avengers is a fictional committee with the purpose to give different outcomes on the marvel saga, For Topic A, this committee will be based on a historical context, so we expect for delegates to not discuss things that has not happened yet in the storyline, in addition, we expect for delegates to create new solutions and to make their use of their delegation in a way that can create a fluid debate for all delegations present. The Sokovia Accords were designed to regulate and monitor the actions of the Avengers and other superheroes in the wake of the destruction caused by the Battle of Sokovia. The Accords aimed to prevent such incidents from happening in the future by holding the Avengers accountable for their actions and requiring them to operate under the supervision of a UN panel. However, the actions of the Avengers cannot be viewed in isolation from the wider context of the threats they were facing. The Avengers were often forced to make difficult decisions and take drastic actions in order to protect the world from powerful and dangerous foes. The delegates of the General Assembly would need to take this into account when making their judgment, and consider whether the Sokovia Accords are a reasonable and effective means of regulating superhero activity. One possible approach would be for the General Assembly to work with the Avengers to develop a more effective and of equitable system oversight and regulation. This could involve a combination of UN oversight, independent monitoring, and input from the Avengers themselves. The goal would be to strike a balance





between ensuring the safety and security of the world, while also respecting the autonomy and independence of the Avengers and other superheroes. judgment of the General Assembly would depend on a range of factors, including the severity of the incidents in question, the actions taken by the Avengers, and the effectiveness of the Sokovia Accords as a regulatory framework. It would be a complex and challenging issue, but one that is of vital importance for the safety and security of the world. On this committee there is a lot of freedom for delegates to use in a strategic way, delegates can search for a resolution of conflict in a peaceful or non peaceful way depending on what the delegations consider best to avoid possible avengers threats that can harm civilians.

# TOPIC (B): JUDGMENT FOR WAKANDA



In the Marvel Cinematic Universe, vibranium is a rare and powerful metal that is highly sought after for its unique properties. It is a nearly indestructible substance that can absorb and dissipate large amounts of energy, making it extremely valuable for military and scientific applications. Wakanda is the only known source of vibranium, and they have guarded its secrets closely for centuries. ### **CAUSES**

of "Black Panther" and "Avengers: Infinity War" changed that. The revelation of Wakanda's resources created a sense of awe and wonder among people around the world. Many realized that the technological advancements and medicinal capabilities of Wakanda could revolutionize fields such as medicine, energy, and transportation. At the same time, however, the revelation of Wakanda's resources also created a sense of fear and jealousy among certain governments and individuals who wanted to exploit those resources for their own gain. t'chaka was killed by an explosion during a United Nations conference, then, their prince and king T'challa died due to an unknown disease and finally (Spoiler Alert), their queen Ramonda died during an attack by Namor's tribe, nevertheless, during this committee, we will be located just before Ramondas death (pre- Black Panther "Wakanda Forever"). All of these losses in Wakanda made its nation more vulnerable, they didn't have someone to govern, theory was unprotected without their black panther and even without their heart herb which were destroyed on the first film of Black Panther by Killmonger.

### **REPERCUTIONS**

The revelation of Wakanda's true nature and resources had significant repercussions on the world. The knowledge that Wakanda possessed the most advanced technology and the world's only source of vibranium, a highly valuable and powerful material, caused a shift in global power dynamics. One of the most notable consequences of the world learning about Wakanda was the desire of other countries to obtain its resources. This was exemplified by the actions of Ulysses Klaue, who attempted to steal vibranium from Wakanda, and the villainous Erik Killmonger, who sought to use Wakanda's weapons to incite a global revolution. The revelation of Wakanda also sparked debates about the country's

responsibility to share its resources and knowledge with the world. Some argued that Wakanda had a duty to use its technology and resources to help other nations, while others maintained that Wakanda had the right to keep its secrets and protect its people. On this topic, The United Nations has summoned the general assembly to discuss the future of Wakanda and how other nations can acquire vibranium for a good use to create peace and security around the globe.

### **CURRENT SITUATION**

Wakanda, has been a point of controversy due to its decision to keep its vibranium resources to itself and not share them with the rest of the world. The first case we saw is from Ulysses Klaue, who was one of the main smugglers of vibranium outside Wakanda. He was born in South Africa and died in London in the hands of Killmonger. He started as a weapon smuggler in South Africa, he has met Tony Stark in the past during a conference of weapons but he never got to an agreement, he had the word "thief" burnt on his neck. Klaue had a special operation base in Johannesburg where he traded with Ultron, nevertheless, this arrangement went south and Ultron cutted his arm thinking it was a trap, after this event, he never appeared until 2018 where black panther was on him trying to capture him. During this persecution, Eric Killmonger got to capture





him first and ended up with his life showing the Wakanda government how "work should be done". Once again, we observe how people try to get Wakanda resources to create weapons, in this particular case, This vibranium was used to create weapons which is a threat to civilians' security and preservation of life.

For the next example we will consider the ultron case very important, however, there is a more relevant event that happened during "Black Panther Wakanda Forever" (The committee is pre-wakanda forever but this will be relevant for the development of the committee). (Spoiler Alert) During "wakanda forever", before Queen Ramonda was executed by Namor, she was once again summoned by The United Nation Security Council to discuss with the queen ¿Why doesn't wakanda share its resources? something which the Queen Ramonda responds: Queen Ramonda (Wakanda Forever)- "It has always been our policy to trade vibranium never under any circumstances. Not because dangerous potential of vibranium, but because of the dangerous potential of use". In addition, days before this event, in Mali, Wakanda has a secret base where they experiment with vibranium. A group of US NAVY seals infiltrated the base with the objective to get Vibranium in which this attempt goes south and Wakandian troops

fight back and captures this soldiers wich coming back to the present, are shown to the United Nations as a clear example of the desperation of other nations to get vibranium in their hands. While some may argue that sharing Vibranium with other countries could be beneficial, it is more likely that it would cause serious global problems. Firstly, sharing Vibranium would create an imbalance of power between countries. Wakanda is already one of the most technologically advanced countries in the MCU, and sharing Vibranium with other countries could lead to some becoming too powerful for others to compete with. This could lead to tension, conflict, and even war. Moreover, Vibranium has been shown to have a variety of dangerous applications, including creating weapons of mass destruction. In the wrong hands, it could be used to cause significant harm to the world. Sharing it with other countries could potentially result in it falling into the hands of evil forces, leading to disastrous consequences. Additionally, Wakanda has kept Vibranium a secret for centuries to protect its people and the rest of the world. If Wakanda were to share Vibranium with other countries, it would be opening itself up to unwanted attention and potentially even invasion. The world would be at risk of losing a valuable resource that has been instrumental in preventing global threats, sharing Vibranium with other countries





would cause more harm than good. The potential for imbalance of power, dangerous applications, and unwanted attention would pose serious problems. While Wakanda may have the capability to share its resources, it has the responsibility to protect its people and the world by keeping Vibranium a closely guarded secret. Furthermore, the existence of a significant source of Vibranium, like Wakanda, could lead to political and economic tensions between nations. Countries could become desperate to obtain the metal and may even resort to armed conflict to get their hands on it. This could destabilization lead to widespread violence across the globe. Overall, the wrong people getting access to Vibranium could lead to disastrous consequences, threatening global peace and security. Therefore, it is essential to keep Vibranium under strict control and prevent it from falling into the wrong hands.

### ORIENTATION AND OBJECTIVE OF THE COMMISSION

For this Topic B, we are looking at a multi-decision liberty for most of the delegates due to how unknown some positions of this topic are. Delegates are expected to make decisions taking into account that these nations cannot overcome Wakandas jurisdiction. Delegates

will have the opportunity to use the case studies explained before to predict what would happen if vibranium is exposed to the world, in addition, delegates will create new allies to create more powerful sides during the committee. We encourage delegates to use resources from other movies apart from Black Panther films to create arguments and evidence. The first step would be to establish a delegation of experts in international law, political science, and culture to assess the situation develop recommendations. This and delegation should include experts on African culture and history to ensure cultural sensitivity and understanding of the context. The first issue to address would be the question of Wakanda's sovereignty. If Wakanda is recognized as a sovereign state, the UN would have limited authority to intervene in its internal affairs. However, if Wakanda is seen as a threat to global security or if there are human rights concerns, the UN could take action to address these issues. One key concern would be the potential misuse of Wakanda's advanced technology, particularly Vibranium, which has the potential to destabilize global power dynamics. The UN delegates would need to determine whether Wakanda is willing to share its technology with other nations or if it intends to keep it exclusively for its own use. If the latter is the case, the UN would





need to consider sanctions or other measures to prevent the spread of Wakanda's advanced weaponry.

Another issue to consider is the treatment of Wakanda's marginalized groups, such as the Jabari tribe, who have historically been excluded from Wakandan society. The UN delegates should encourage Wakanda to address these internal inequalities and promote greater social cohesion. Overall, the UN's approach to Wakanda should be respectful of its sovereignty and cultural traditions while also promoting global security and human rights. This would require a delicate balance of diplomacy and international cooperation, guided by a commitment to justice and equality for all. Finally and most important is for delegates to enjoy this topic and let their creativity expand to make a fluid debate for yourselves and for the whole committee, good luck.
